
Improving the Student Teacher Experience

Mentor Teachers:

- Have clear expectations for themselves and the students
- Training is mandatory
 - Use techniques to reinforce areas the student is studying
- Are given stipends for participating
- Are identified as "ready" after an assessment is completed

Learning Grove Expands & Improves Our Role in Teacher Preparation

- Learning Grove will develop an orientation that includes LG rules and an agency overview
- Mentors are given time out to meet with students to discuss what they are studying and how it aligns to what is happening in the classroom
- Learning Grove "Hot Topics" are developed in addition to the university's curriculum. Topic examples include brain research, LG strategies to support social and emotional development and constructivism

MAIN GYM ROOF REPAIR/REPLACEMENT

 Following Controlling Board approval in April, the general contractor has begun the process of ordering materials. Start of construction is pending confirmation of delivery of roofing materials. Replacement of the roof is anticipated to take approximately 90 calendar days following delivery of materials.


Cincinnati State Fiscal KPI Dashboard

22.35 FY22 Budget Amendment No. 2

WHEREAS, the Board of Trustees is required by to Ohio Statute to review and approve the annual budget for Cincinnati State Technical and Community College, and

WHEREAS, approved the Fiscal Year 2022 budget via Board of Trustees Resolution 21.63 on June 22, 2021; and

WHEREAS, amended the Fiscal Year 2022 budget via Board of Trustees Resolution 22.07 on January 25, 2021; and

WHEREAS, the State of Ohio requires that increases in expenditures be authorized by the Board of Trustees; and

WHEREAS, the College has generated additional instructional fee revenue compared to the budget based on Spring and Summer Semester 2022 enrollment; and

WHEREAS, the President, Executive Team and Finance Committee recommend Board of Trustees increase allowable expenditures equivalent to additional instructional fee revenue compared to the budget based on Spring Semester 2022 enrollment.

RESOLVED: The Board of Trustees authorizes an increase in expenditures equivalent to:

- \$461,811 (the positive variance in actual fiscal year 2022 instructional fee revenue from Spring Semester 2022, excluding CCP & WDC); and
- \$261,523 (the positive variance in actual fiscal year 2022 instructional fee revenue from Summer Semester 2022, excluding CCP & WDC through the first day of classes).

President Posey shall have discretion to allocate expenditures authorized by this resolution, based upon the advice and counsel of the Finance Committee. President Posey and College's authorization to increase expenditures is limited to achieving a net surplus no less than \$606,957 (the amount stipulated in board resolution 21.63), and successfully achieving the colleges fiscal year 2022 priorities related to cash reserves and senate bill 6 composite score. The College's interim financial reporting will be tracked against the budget authorized by resolution 21.63.

Budget and College Mission

Cincinnati State provides access, opportunity, and support in achieving success for individuals seeking exceptional technical, transfer experiential/cooperative education and workforce training.

The annual budget process of Cincinnati State allocates fiscal resources in a manner sufficient to support the College's mission (student-focused, accessible, quality technical and general education, academic transfer, experiential and co-operative education and workforce development) and meet the obligations of the College and its stakeholders.

Fiscal Planning Priorities and Key Fiscal Metrics

• As approved by the Board of Trustees via Resolution 22.22, March 22, 2022

- Support student success through the allocation of fiscal resources sufficient to successfully implement the College mission and educational programs; and
- Prioritize fiscal support of investments necessary to stabilize and grow enrollment, maintain and improve aging facilities, and implement strategic planning projects; and
- Maintain fiscal sustainability as evidenced by key fiscal metrics of: Annual Positive Cash Flow, Annual Positive Net Surplus, and Annual Senate Bill Score no less than 3.50 and on a long-term trend to exceed 4.00




Sources of Revenue (Actual FY21 & FY22 LTM)



Excluding Stimulus, Insurance Claim, Pass Through Grants, GASB 68/75, Transfers and State Capital Activity







End of year reports

As we conclude the 21-22 academic year, Faculty Senate is working to collect final reports from all shared governance committees. This will provide us with insight into the important work that has been done this year and what future directives and goals will need to be in the future.

Adjunct Pay Recommendations

In January 2022 an Adjunct Pay Taskforce was formed to research adjunct pay at local institutions as well as those around the state to compare to the current rate offered at Cincinnati State. Part of this work including surveying Program and Department chairs as well as adjunct faculty with the aim of identifying barriers to staffing courses including adjunct recruitment, retention, availability, and pay. As adjunct faculty make up 60% or more of the instructor base at the College, this work has been adopted as a priority of the Faculty Senate.
