Benjamin Cook

Benjamin Cook is an artist and educator from Cincinnati, OH. He earned his MFA from the University of Illinois at Urbana-Champaign (2017) and his BFA from the University of Louisville (2012). Ben is an adjunct professor at the Art Academy and teaches in the First Year Experience and Painting departments. Ben's paintings, and online-based projects have been exhibited nationally and internationally at Hashimoto Contemporary (LA), Zg Gallery (Chicago), Gallery COA (Montreal), The Rochester Museum of Fine Arts (NH) Cidney Rucker Gallery (NY), as well as in publications including the Art Newspaper, Artnet, Forbes, New American Paintings, and LA Weekly. Cook is the founder of Social Distance Gallery, an Instagram-based project that cataloged and archived 2020 student thesis exhibitions that were canceled due to the Covid 19 pandemic.

Emily Hanako Momohara

Emily Hanako Momohara is a mixed race Japanese American, artist, educator and activist. Momohara serves as Associate Professor of Studio Art at the Art Academy of Cincinnati and has a robust studio practice. Her role as faculty is always evolving and centers student agency. She claims to "profess" nothing, but curate experiences for students to self-evaluate, problem solve and be lifelong learners. She is dedicated to resilience-based and feminist pedagogies. Momohara's creative research centers around issues of heritage, multiculturalism, immigration and social justice. She has exhibited internationally, most notably in the Changjiang International Photography & Video Biennale in Chongqing, China and a 2-person exhibition at the Japanese American National Museum titled Sugar Islands. In 2021, she was awarded a Truth and Reconciliation Grant from Artworks for her film on the life of Namba premiered in July. She has lived in Cincinnati since 2006 and serves as a co-lead on the OPAWL Cincinnati Caucus, volunteers for the Japanese American Citizens League Cincinnati Chapter and is a Board of Trustee at the Cincinnati Contemporary Art Center. In her free time, Momohara loves to hike and camp with her family.

CHATFIELD COLLEGE

Lynn Hanson

Lynn Hanson received a BA in Anthropology (1991, Magna cum Laude) and an MA in History (2002) from Wright State University (WSU). In 2004, she received the Outstanding Alumnus Award from WSU's College of Liberal Arts. As the Vice President of Collections and Research at the Dayton Society of Natural History (DSNH), Hanson oversaw operations for the Collecting departments at the Boonshoft Museum of Discovery, and at SunWatch Indian Village and Fort Ancient State Memorial, working closely with several Native American nations. She shepherded the renovation of the planetarium, a Visitor's Center, and an indoor zoo. Hanson also presented numerous informal education school programs for visiting groups. She worked closely with interns, overseeing work at archaeological excavations and in reconstruction at SunWatch Indian Village. From 2006-2019, Hanson taught at WSU for the Anthropology Department, and for the History Department from 2007-2019. In 2009, she was a founding member of the World Heritage Ohio Steering Committee, which submitted its Hopewell Ceremonial Earthworks application for UNESCO World Heritage listing this year. She is past president of the Ohio Archaeological Council. Hanson began instruction at Chatfield in 2018, offering a variety of courses in History, plus Chatfield's first semester course, Cornerstone. In May 2022 she was nominated by Chatfield's graduates to receive the Sister Agatha Fitzgerald Excellence in Teaching award. As a first-generation college graduate, Hanson believes that the key to success in learning lies with both the instructor and the student: both are responsible for putting in the work. The instructor must provide honest feedback, evaluation, and be patiently persistent to keep students focused on progress towards degree.

Beth Hamon

Dr. Beth Hamon is a full time Professor of Nursing at Cincinnati State Technical and Community College Bethesda School of Nursing. She is the lead faculty for the senior nursing students guiding them through advanced Medical Surgical Theory Content and their clinical role transition experience. She loves challenging the students with evolving case studies and virtual simulations. Dr. Hamon challenges the students to achieve their own personal and professional goals. Nursing graduates from Cincinnati State have a strong NCLEX pass rate and overwhelmingly positive employer evaluations. Dr. Hamon is a long-standing member of the Nursing Program Curriculum Committee. In this role, she makes certain the Program Learning outcomes are linked to both course and topic learning outcomes. She audits course documents to verify compliance with the Ohio Board of Nursing as well as Accreditations standards. Degree mapping and program assessments are an important role of the curriculum committee. Dr. Hamon was nominated by her peers in the Health and Public Safety Division to represent them as Faculty Senator. As a Senator, she participates in the shared governance model of college leadership. The Faculty Senate ensures a positive exchange of ideas between faculty and administration facilitated by mutual respect. Cincinnati State is in the process of developing an RN-BSN program. Dr. Hamon has been appointed as program chair. In this role, she collaborates with a team of faculty to develop program learning outcomes, course learning outcomes and course content in line with best practices in nursing education. In 2022, Dr. Hamon was awarded the prestigious House/Bruckmann Faculty Excellence Award.

His design, research, and design-build projects for Fallingwater, Bear Run, PA and Le Centre de Documentation sur les Migrations Humaines, Luxembourg have been exhibited and published internationally. Select publications include: The Journal of Architectural Education (MIT Press), 306090 07: Landscape Within Architecture (Princeton Architectural Press), the Italian design journal AND, and most recently, T-Squared: Theories and Tactics of Architectural Design (Intellect Books/University of Chicago Press). Reynolds was a contributing author to two books, The Nature of Circumstance (Rizzoli) and Fallingwater (Rizzoli). Professor Reynolds has received numerous teaching awards including: The Miami University E. Phillips Knox Distinguished Teaching Award, The Miami University School of Fine Arts Crossan Hayes Curry Distinguished Educator Award, and The Association of Collegiate Schools of Architecture Collaborative Practice Award. Prior to joining Miami University, Professor Reynolds pursued architectural practice with two internationally recognized firms, Eisenman-Robertson Architects, New York, NY and Charlottesville, VA and Tigerman, Fugman, McCurry Architects, Chicago, IL.

Deepak Dawar

A Ph.D. in computer science and a former software engineer, Dr. Deepak Dawar has had a varied professional career. Although he thoroughly enjoyed the challenges of building and delivering software, he became ever more aware that he thrived in situations where he could train and coach new hires and coworkers. Therefore, in the middle of his career, he switched from industry to academia, completed a master's degree, then a Ph.D., and started working as an assistant professor at Miami University. Dr. Dawar is committed to revolutionizing how computer programming is taught. He has a passion for computer programming and always looks forward to creating novel techniques that can enhance learning among students. His primary area of research is Artificial Intelligence (A.I.). As he evolved as a teacher, he started working out a plan to apply his working knowledge of A.I. to education, especially in computer programming instruction and student learning. As a result, he began exploring relevant scholarship and restructured a part of his research around effective pedagogy and state-of-the-art artificial intelligent tutors. Dr. Dawar is also concerned about the internationally accepted problem and pedagogical concerns of high failure and non-participation rates in programming classes. To address this issue, he researched and subsequently published novel instructional techniques which have proved to be of considerable classroom value. Dr. Dawar aims to get high school students interested in STEM fields by introducing them to simple bot development. In these ways, his research in A.I., bots, and pedagogy helps to value future students and the community.

Elliott Jardin

Dr. Jardin is an Assistant Professor at the Miami University Regionals. He was recently recognized by the University for his online teaching by receiving the E-Campus Excellence in Online Teaching Award in 2022. He graduated from Oregon State University in 2013 with a B.S. in Psychology, graduating with honors and with distinction as a research fellow. He then graduated from Cleveland State University with a Ph.D. in 2018 under the mentorship of Dr. Phil Allen. In 2019, he spent a year at Skidmore College as a Visiting Assistant Professor before joining the Miami University Regionals in 2020. At the regionals, Dr. Jardin conducts research on individual differences in cognition and neuroscience. The majority of his work focuses on agerelated differences in attention, memory, and perception. He shares his lab results and interviews experts in the field of neuroscience on this Brain Health Podcast on Spotify. At the University he is the faculty advisor for the Psychology Club and helps lead weekly events for them. His two favorite classes to teach are cognitive aging and statistical research methods. In 2016 he developed a YouTube Channel that helps guide students through their statistics courses. Outside of work, Dr. Jardin enjoys spending time with his family and playing sports.

Mike Obert

Dr. Mike Obert is an Assistant Professor in the Doctor of Physical Therapy Program at Mount St. Joseph University. He has been teaching full-time at the Mount since 2014, and his current teaching responsibilities include Clinical Exercise Physiology, Basic Examination and Evaluation, Applied Orthopedics I & II, and Advanced Topics in Manual Therapy. He is also a practicing clinician who earned his board certification as an Orthopedic Clinical Specialist in 2009. He serves as academic faculty for the Cincinnati VA Medical Center Orthopedic Residency program. He earned his Doctorate of Health Science from the University of Indianapolis in 2020, where his dissertation focused on determining if clinical reasoning skills in DPT students could serve as a predictor of success in the DPT program. His teaching style is a studentcentered, personal approach that challenges the students to think critically, while displaying caring and compassion for them as individuals. In addition to his teaching and clinical responsibilities, his family founded and runs a nonprofit charitable organization, Payton's Lemonade Stand, which is focused on empowering the next generation of philanthropists to sweeten the lives of kids facing medical, personal, and economic hardships. Through his service work, he has encouraged his students to get involved in philanthropy and giving back to the local community. Sara Drabik

Sara Drabik is an Associate Professor in Electronic Media & Broadcasting and the Media and Journalism Program Head at Northern Kentucky University. She has been an educator for over two decades, serving the greater Cincinnati community as the Education Director for Media Bridges Community Media Center before joining the faculty at NKU in 2009. She teaches courses in Documentary Film analysis and production and leads students and faculty on study abroad experiences around the globe. Her classes are based on experiential learning opportunities that connect students with communities, both locally and abroad. A graduating senior noted: "Being in a class taught by Sara Drabik was a priority of mine every semester until I graduated because of her dedication and passion for teaching. Being a professor is not just a job or a career to Sara, it is a commitment, and in a sense, a calling and purpose. Sara has always gone above and beyond to support her students." Ahmed Elgafy

Conveying an outstanding spirit of teaching, and service to his work with the University of Cincinnati, Ahmed Elgafy, PhD, Professor-Educator at the Department of Mechanical and Materials Engineering, has built a long history of impact on UC since 2008. Teaching over hundred courses that incorporate 25 different curricula, developing new curricula in the fields of renewable energies and nanotechnology in the underage and graduate levels, and supervising more than 120 senior and graduate students has helped shape the future of UC's students. Elgafy's excellence in teaching has been recognized by 13 teaching awards, with the most recent one: The University of Cincinnati Distinguished Teaching Professor Award, 2022. Elgafy has tremendous service contributions in 18 different committees at the Department, College, and University levels. Prominent among them; ABET coordinator, MET program since 2010; (the accreditation has been granted for two consecutive rounds, and he is working on the third one). He is a reviewer for grant proposals submitted to NASA, DOE, and many other national and international institutions. His merit in service has been recognized by 3 service awards. Even though Elgafy's primary responsibility is teaching, he continues to serve the mission of UC through contribution in research in the fields of nanocomposites, advanced materials, and engineering curricula assessment. He has published 1 book chapter & 41 articles; which some of them appear in highly ranked journal, "Carbon", with an impact factor of 9.6.

Andrew R. Lewis

Dr. Andrew Lewis is Associate Professor and Assistant Director in the School of Public and International Affairs at the University of Cincinnati (UC). Prof. Lewis joined UC in 2012, after completing a PhD from American University. He teaches courses in American politics and law. He also founded the Law & Society major and Legal Studies certificate in partnership with UC Law. Prof. Lewis has been honored for his teaching and mentoring, receiving the University-wide Mrs. A.B. Dolly Cohen Award for Excellence in Teaching, the College of Arts & Sciences Rising Star Award, the Undergraduate Mentor award, and the Turner Scholars Faculty Honoree award. Prof. Lewis is an expert in religion, law, and politics in the U.S. and serves as Co-Editor-in-Chief of the political science journal *Politics & Religion*. His book *The Rights Turn in Conservative Christian Politics: How Abortion Transformed the Culture Wars* won the American Political Science Association award for the Best Book on Religion and Politics. He has published in peer-reviewed journals and popular outlets, including *The New York Times, The Atlantic*, and *USA Today*.

David E. Rapien

Associate Professor-Educator and University of Cincinnati alumnus David Rapien (BBA '95, MBA '96) has been a Carl H. Lindner College of Business faculty member since Fall 2013. Rapien works in the Department of Operations, Business Analytics, and Information Systems, and serves as the first Kolodzik Business Scholars House Director in the Lindner Business Honors Program. For the previous seven years, he served as the Information Systems undergraduate program director and doubled the size of the program. Rapien taught at Elder High School for 17 years and has coached for 32 years. He hones his industry skills through multiple software and consulting companies he founded and has been leading for over 30 years. He has taught courses at high schools and Universities around the world and has presented for TEDx, Analytics Summits, and International Symposiums. Rapien has won numerous teaching, innovation, and mentoring accolades, including awards from the Lindner College of Business and UC's Mrs. A.B. "Dolly" Cohen Award for Excellence in Teaching and The George Barbour Award for Good Faculty Student Relations.

Krista E. Wood

Dr. Krista Wood is a Professor of Physics at UC Blue Ash who is passionate about teaching and making physics accessible to all students. In her classes, she creates a culture of collaboration and caring to break down barriers to learning. Students work in small groups to develop their problem-solving and critical thinking skills. She emphasizes that it is OK to be wrong! In fact, it is necessary to encounter challenges to overcome, when learning new concepts and skills. Dr. Wood uses research-based instructional strategies in her classes and shares her research results locally, regionally, and nationally at conferences, workshops, and publications. She regularly shares pedagogical materials, mentors other faculty, and provides guidance in their pursuit of improving their teaching practice. She was inducted into the UC Academy of Fellows for Teaching and Learning in 2017 and has been awarded the 2022 Distinguished Teaching Award. In her work to improve physics teaching, she currently serves on the American Association of Physics Teachers (AAPT) Board of Directors and as Past President of the Southern Ohio Section of AAPT Board. She is on the leadership team for a National Science Foundation Grant to create an Organization of Physics at Two-Year Colleges (OPTYCs) that will provide professional development opportunities, mentoring, and research opportunities for twoyear college physics faculty. Dr. Wood is co-leading the development and implementation of an 18-month New Faculty Development Series and a Leadership Institute with mentoring to support faculty implementation efforts.
