



## Capital Projects Update January 2024

#### MAIN BUILDING AIR HANDLER UNIT (AHU) REPLACEMENT

- AHU 24 (serves basement, near Fitness Center) to be completed in January
- AHU 1 Serving Main Building basement and 220-230/320-328A to be completed in February

#### **CLIFTON CAMPUS EXTERIOR IMPROVEMENTS AND WAYFINDING**

- Foundations for all exterior signage have been poured, and entrance signs to be completed in February.
- Mesh signage on Parking Garages has been installed, with mesh lighting next in January
- Remaining work on landscaping, and Main building Automotive Wing garages will resume in late Spring.

#### PRACTICAL NURSING SKILLS LAB RENOVATION






### **Clifton Campus Moves**

- **CState Complete:** New Office funded with Title III funds for furnishings in ATLC 201, converting a classroom to this temporary office space






## LPN Skills Lab Floor Plan (Main 266, 268, 270)




#### Cincinnati State Fiscal KPI Dashboard


Year-Over-Year Change in Unrestricted Cash\* \$96,985

## **24.06** FY25 Budget Planning – Affirmation of Fiscal Priorities



### 24.06 Affirmation of Fiscal Planning Priorities

**WHEREAS**, the Board of Trustees establishes fiscal planning priorities during the annual budget process taking into consideration recommendations of the President, Executive Team, and Finance Committee.

WHEREAS, the Board of Trustees has deliberated fiscal planning priorities for the Fiscal Year 2025 budget, also taking into consideration recent College fiscal performance, enrollment, Senate Bill 6 Composite Score, and comparable fiscal performance of Ohio Community Colleges.

**WHEREAS**, the Board of Trustees has determined that the minimum goal for Senate Bill 6 Composite score should be increased.

**NOW, THEREFORE BE IT RESOLVED**, the College fiscal planning priorities for Fiscal Year 2025 shall be:

- 1. Support student success through the allocation of fiscal resources sufficient to implement the College mission and educational programs successfully; and
- 2. Prioritize fiscal support of investments necessary to stabilize and grow enrollment, maintain and improve aging facilities, and implement strategic planning projects; and
- 3. Maintain fiscal sustainability as evidenced by key fiscal metrics of Annual Positive Cash Flow, Annual Positive Net Surplus, and Annual Senate Bill Score no less than 3.50 and on a long-term trend to exceed 4.00





### **24.07** Budget Amendment

WHEREAS, the Board of Trustees is required by Ohio Statute to review and approve the annual budget for Cincinnati State Technical and Community College and

WHEREAS, approved the Fiscal Year 2024 budget via Board of Trustees Resolution 23.50 on June 27, 2023; and

WHEREAS, the State of Ohio requires that the Board of Trustees authorize increases in expenditures; and

WHEREAS, the President, Executive Team and Finance Committee recommend that the Board of Trustees increase allowable expenditures equivalent to additional revenue compared to the budget subject to the limitations below.

**RESOLVED:** The Board of Trustees authorizes an increase in expenditures equivalent to:

\$560,524 Fall and Spring undergraduate tuition and fees over budget (excluding CCP & WDC)

\$365,000 of the expenditures shall be allocated to deploy a proof-of-concept marketing program targeted at specific programs to increase enrollment by 235 students for the Fall Semester of 2024. President Posey shall have the discretion to allocate expenditures beyond the marketing initiative authorized by this resolution, based upon the advice and counsel of the Finance Committee.

The authorization to increase expenditures is limited to achieving a net surplus of no less than \$269,742 (the amount stipulated in board resolution 23.50), and successfully achieving the fiscal year 2024 priorities related to cash reserves and Senate Bill 6 composite score. The College's interim financial reporting will be tracked against the budget authorized by resolution 23.50.





## 24.08 Vendor Contracts Approval



#### 24.08 Vendor Contracts

**WHEREAS** the Board of Trustees establishes expectations regarding accountability and transparency and has adopted a Contract Management Policy.

WHEREAS the College has complied with the Ohio Revised Code, the Ohio Administrative Code, and Ohio Revised Code 123.10 in its procurement processes, and in doing so, recommends contracts as follows:

- At Bay. Cyber Insurance, \$3M policy, \$25K deductible. \$55,785 funded via general funds.
- Schrudde & Zimmerman, LPN Skills Lab Renovation General Contractor. \$305,237 funded via Hamilton County ARPA grant.
- Educational Furniture, Title III grant office furniture. \$50,000 funded via Title III grant.
- Locale. Program marketing. \$340,000 funded via general funds. 4.
- Firrelli. Flexpert contract services. \$\$307,200 funded via general funds. 5.
- Krish Services Group. Intranet build-out and annual support. \$77,460 funded via general funds 6.
- Siemens. Clifton campus building services automation, three-year renewal. \$210,577 funded via operating funds.

### 24.09 Adjunct Pay

WHEREAS the College seeks to attract and retain highly qualified adjunct instructors to ensure high-quality instruction of technical and general education courses;

WHEREAS the College's current adjunct pay rates of \$620.00 per unit for new adjunct professors and \$620.00 per unit for seasoned adjunct professors are the lowest among institutions of higher education in the Greater Cincinnati region;

WHEREAS the College seeks to increase the adjunct pay rate in a phased approach until the College's adjunct pay rate is competitive with other institutions of higher education in the region;

NOW THEREFORE BE IT HEREBY RESOLVED that an adjunct pay rate of \$640.00 unit will be implemented for all adjunct instructors beginning summer of 2024.

### **Super RAPIDS Funding \$1.7 million**

**\$696,000** - state-of-the-art training equipment for our mechanical, electro-mechanical, and electrical engineering technology programs; focus is Advanced Manufacturing, led by the aerospace and automotive industries, and addresses Ohio's growing semiconductor industry

\$685,000 – to become a training center for technicians with build out of labs and expansion of the Broadband/5G network in SW Ohio in collaboration with Miami Uni and Great Oaks; part of a statewide project by the Governor's Office of Workforce Transformation; represents a new and promising area for the college.

**\$378,000** - fund 5G/Broadband operational start-up costs including a project manager and instructor, plus funds for administration and marketing
