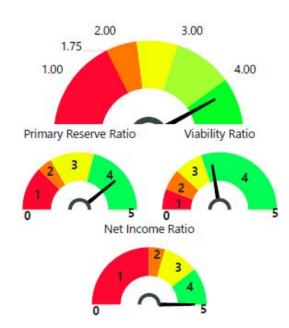

### **FY22 Budget Fiscal Planning Priorities**

#### As Approved by the Board of Trustees, January 2021

- 1. Support student success through the allocation of fiscal resources sufficient to support the College mission and educational programs; and
- 2. Maintain fiscal sustainability as evidenced by key fiscal metrics of: Annual Positive Cash Flow, Annual Positive Net Surplus, and Annual Senate Bill Score no less than 3.00 and on a long-term trend to exceed 4.00; and
- 3. Prioritize fiscal support of investments necessary to stabilize enrollment, maintain aging facilities, and implement strategic planning projects.

### **Key FY22 Budget Assumption #1**

#### Instructional Fees (Enrollment, excluding CCP and WDC)

- Instructional Fees Average 35% of Total Revenue
- Instructional Fee Revenue is based on Credit Hours x Tuition Rate
- FY22 Budget Assumptions
  - AY21-22 decreased 8.5% compared to AY20-21, No Change to Tuition Rate
- Credit Hours Declining Since Academic Year 2012-2013
  - Signals of Enrollment Stabilization?
    - Spring 2020 and Summer 2021 first YOY increases since 2013
    - AY20-21 smallest YOY change (-3.70%) since conversion to semesters

### **FY22 Final Budget**

- President Posey and the Executive Team request approval of the final budget via Resolution 21.63
  - Approval recommended by Finance Committee
  - The FY22 Budget meets the fiscal priorities established by the Board of Trustees in terms of mission, cash flow, net surplus, and senate bill 6 score
  - Declining enrollment and SSI will continue to put pressure on budgets, however, if enrollment stabilizes or grows the College is in a good position to avoid expense reductions or invest in growth opportunities
  - Federal Stimulus is treated as 1x occurrence and not relied upon for long range operating budget relief



### **Resolution 21.63**

#### Fiscal Year 2022 Budget

**WHEREAS**, the Board of Trustees is required by to Ohio Statute to review and approve the annual budget for Cincinnati State Technical and Community College, and

WHEREAS, the Board of Trustees have determined that the Fiscal Year 2022 Budget as attached and presented by the President and Executive Team supports the College mission and strategic plan through sufficient fiscal support of the educational programs; and

WHEREAS, the Board of Trustees have determined that the Fiscal Year 2022 Budget as attached meets the fiscal planning priorities recommended by the President, Executive Team, and Finance Committee and approved by the Board of Trustees with respect to annual positive cash flow, annual positive net surplus, Senate Bill 6 Composite Score no less than 3.00, and fiscal support to stabilize enrollment, mitigate aging facilities, and implement strategic planning projects; and

WHEREAS, the President and Finance Committee have reviewed detailed Fiscal Year 2022 Budget assumptions and allocations of revenue and expenses across the College's Funds, Departments and Object Codes; and

**WHEREAS**, the President, Executive Team and Finance Committee recommend Board of Trustee approval of the Fiscal Year 2022 Budget; and

**WHEREAS**, the Fiscal Year 2022 Budget is contingent upon passage of the Ohio Fiscal Year 2022-2023 Biennium Operating Budget containing State Subsidy for Instruction funding at least equal to funding in the Ohio Governor, Ohio House of Representatives, and Ohio Senate versions.

**RESOLVED:** The Board approves the Fiscal Year 2022 Cincinnati State Technical & Community College Budget as presented in Exhibit A (attached).

The Fiscal Year 2022 Budget net surplus equals \$606,957. The Finance Department shall prepare a Monthly Financial Report to the Board of Trustees. If the Board does not meet, the Monthly Financial Report will be distributed to the President and Finance Committee, and upon request, to any member of Board of Trustees. The Monthly Financial Report shall be prepared in a format and with content similar to Monthly Financial Reports distributed in Fiscal Year 2021.

The College's minimum cash reserves shall be monitored by the Finance Committee and shall exceed the total of (1) restricted cash; (2) grant, contracts, and state reserves; (3) cash reserves against liabilities as directed by the Finance Committee; and (4) and board designated contingencies for debt service, deferred maintenance, payroll, and payables.



#### **Resolution 21.64**

#### **Competitively Bid Requisitions**

**WHEREAS**, Board Resolutions 80.46 and 80.48 require the College to competitively bid requisitions in excess of \$5,000 with exception for requisitions from specified state contracts;

**WHEREAS,** upon surveying other State of Ohio institutions of higher education, all other institutions have a higher limit for competitive bids in comparison to Cincinnati State;

**WHEREAS**, state and federal requisition requirements for competitive bids also exceed Cincinnati State's policy;

**WHEREAS**, the College policy regarding competitive bids has been unchanged in over 20 years, and the President and Executive Team recommend increasing the limit to increase efficiency in the Procurement process; and

**NOW, THEREFORE BE IT RESOLVED** that the Board of Trustees of Cincinnati State Technical and Community College establish that, effective July 1, 2021, any requisition of \$10,000.00 or more must be competitively bid unless bought from one of the following contracts: State of Ohio Department of Administrative Services (DAS), State of Ohio Inter-University Council (IUC), State of Ohio Educational and Institutional (E&I), Sourcewell Cooperative Purchasing, Omnia Partners Public Sector.

#### **Resolution 21.65 Contract Approval**

WHEREAS, the Board of Trustees establishes expectations with regards to accountability and transparency, and has adopted a Contract Management Policy.

- Orion Innovation, not to exceed \$50,000 to provide strategy, design and technical implementation for the redesign of the Daily News 3. (internal) website. (Federal Stimulus and General Funds).
- Skanska USA Building, Inc., not to exceed \$509,044.00 for Owner's Representative/Project Management Services for capital projects to 4. include: a) Replacement of eight (8) air handlers in Main Building; b) Replacement of fire loop on Clifton campus; c) WDC manufacturing lab upgrades on Evendale campus; d) Main Building gym roof repair/replacement; and e) Allied Health Simulation Lab design, bid and construction (Federal Stimulus and Capital Funds);
- Southwestern Industries, Inc., dba TRAK Machine Tools, \$155,989.40 for six (6) knee mills for WDC Manufacturing Lab (Capital 5. Funds);
- Tritek Machinery, division or Robert J. Paul Corp., \$99,465.00 for six (6) heavy duty high speed precision geared head lathes for WDC 6. Manufacturing Lab (Capital Funds)

### Cincinnati State-NKU Articulation Agreement

#### **NKU & Cincinnati State Sign New Articulation Agreement**

- > Signed today, June 22, 2021, by Pres. Posey and Pres. Vaidya
- Effective Fall 2021 (reviewed annually)
- Nearly 50 articulated degree pathways from Cincinnati State to NKU

#### **Key Features**

#### **Dual Admission**

- Clear path to a bachelor degree ... providing students certainty and confidence
- > Access to NKU resources (e.g. admissions assistance, on-campus housing, Campus **Recreation Center)**
- Option of 4 courses on NKU campus, at Cin State tuition rate, while still a Cincinnati State student.

#### **In-State Tuition**

In-state tuition to NKU after graduation from Cincinnati State.

#### Data Sharing

NKU will share data to allow Cincinnati State to evaluate scale and academic success of our students who continue on to NKU to pursue a bachelors.

While transfer issues and tuition are potential barriers for students wanting to make a seamless transition from community college to a four-year institution, the region is fortunate to have two superior educational partners — NKU and Cincinnati State — focused on building a talent pipeline for the companies we are working with to locate or expand here.
