Main Building Recovery February 23, 2021 Board of Trustee Update



Strategic Priorities Related to Crisis

- 1. Continuity of Mission and Academic Instruction
- 2. Restoration of Systems Necessary to Occupy Main Building
- 3. Management of Insurance Claim and Collection of Insurance Proceeds



Continuity of Mission and Instruction

- Focus on preparing Main to be re-occupied in early May, but in concert with Responsible Return to Work Plan to ensure COVID precautions as may be needed
- Develop with Deans and Managers progression of re-occupancy for Summer and Fall Semesters
- Surge Purge to remove unneeded materials/equipment to ensure access to electrical, and ease of deep cleaning



Restoration of Systems to Occupy Main Building

- Chillers (Main & HPB Building cooling) replacements received; chilled water lines being installed
- Main Building Hot Water Supply whole building system designed & heat exchangers received
- Air Handlers all units (50) undergoing assessment and repairs as may be needed; replacements for 3 destroyed units located in tunnels scheduled for delivery mid-March; identified 8 units that do not meet COVID air circulation standards – design for replacement underway
- Electrical Supply A & B Wings completed; C Tunnel complete; D tunnel 60% complete; E-G tunnels and 3-4 stories above remaining, along with completion of restoration of permanent power to mechanical room
- Elevators repairs and inspections of 3 damaged units complete; Gym elevator awaiting parts, repair and inspection.
- Cooling towers & pump house repairs underway including electrical and control panels
- Fire Loop replacement design underway in preparation of putting out for bid



Restoration of Systems to Occupy Main Building

- Restoration of Damage to Fitness Level (drywall, carpet, cove molding) complete
- Asbestos & insulation removal (100% complete); re-insulation 60% complete
- Building automation controls complete to new boilers; ongoing as new systems come online
- Consider and Execute Opportunities to Improve Infrastructure for Long Term Continuity of Main Building



Management of Insurance Claim

- Claim filed with Carrier in September
 - Carrier: Traveler's
- College is Coordinating with Carrier and Adjuster to Determine Losses
 - Policy and Limits: Full Replacement Value, General Policy Limit is equal to building and contents value
 - Carrier has not invoked any exclusions or limitations to date
 - Carrier has continued to make cash advances to College
- OFCC Declaration of Public Exigency and OBM Notice of Intent to Reimburse Provide Procurement flexibility and ability to Reimburse using Capital Appropriations to cover any amount not reimbursed by insurance





Strategy

- As we combine and leverage capital and stimulus dollars we can provide a safe, modern Main building and support remote instruction and operations consistent with the master plan and strategic priorities that existed prior to COVID and the Main Building Flood.
 - Due to water damaged building systems, we have had to reprioritize funds that were intended for other Main building projects.
- This strategy allows us to fully utilize Stimulus funds, optimize capital appropriations and accelerate our master planning.


