

FY21 Audit Update

Management Letter

Proper Encumbering

In Ohio Rev. Code Section 5705.41(D)(1) prohibits a subdivision or taxing entity from making any contract or ordering any expenditure of money unless a certificate signed by the fiscal officer is attached certifying that the amount required to meet any such contract or expenditure has been lawfully appropriated and is in the treasury, or is in the process of collection to the credit of an appropriate fund free from any previous encumbrance.

Proper prior certification by the fiscal officer or following one of the approved exception methods could not be verified in <u>five of the forty disbursement transactions tested</u>.



Capital Appropriations Update

- Additional Request for State Federal Stimulus Allocation submitted to ODHE and OACC
 - Significant Unallocated Federal Stimulus Funds available for Allocation by the State of Ohio being requested by OACC/ODHE for Capital Purposes
 - Requests for 3 potential projects (Harrison, Butler Co., WDC) and 37 business and community supporters highlighted
 - Likelihood of Success, Amount of Funding, Timing: TBD





21.123 FY21 Efficiency Report



FY21 Efficiency Report Resolution 21.123

- An efficiency report is statutorily required to be submitted to ODHE annually and approved by the Board of Trustees (House Bill 49, Section 381.50).
- The efficiency report is an annual process to assess and document affordability and efficiency in higher education.
- FY21 efficiency report documents \$9,005,487 in savings at Cincinnati State compared to the FY17 Baseline.
- President and Executive Team Request the Board of Trustees approve Resolution 21.123 to accept the report as presented.





21.124 Approval of Vendor Contracts



Contracts Resolution 21.124

College Requests Board Approval for the Following Contracts as required by Board Resolution.

- John Tafaro, Interim Vice President Administration, funded from General Fund, \$82,500;
- Trane USA, ATLC Chiller Compressor Repair, funded from General Fund \$116,557; and
- Miami University, Tech Prep Coordinator, grant funded \$60,000.





21.125 Board Approved Exceptions to Certification Requirements



Exceptions to Certification Resolution 21.125

- Ohio Revised Code Chapter 5705, and the Ohio Auditor of State 2022 Ohio Compliance Supplement Section 1-2 as applied by the Ohio Auditor of State, and the College's Procurement Policy requires appropriation and certification prior to the date of order or contract; and
- Ohio Revised Code, as interpreted by the Ohio Auditor of State offers exceptions to this requirement if the appropriation is certified by the Board of Trustees;
- This exception is generally intended for emergency procurement; and
- Resolution 21.125 lists invoices that require approval by the Board of Trustees as required by Ohio Compliance Supplement Section 1-2.

I do not see this shortage as a one- or two-year issue, but a decade issue.


