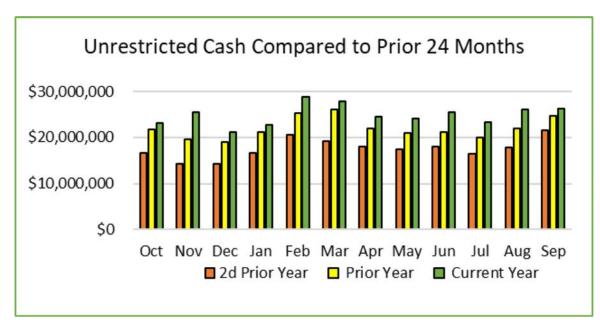

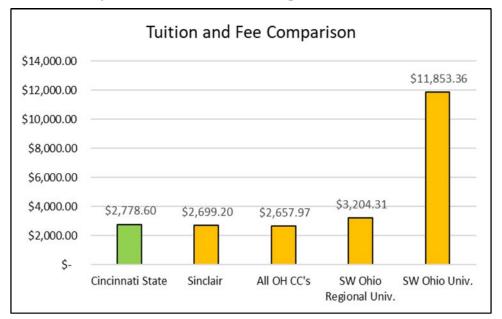


#### **21.110 Tuition Resolution**



#### **Tuition Resolution 21.110**

- House Bill 110 allows Cincinnati State to increase Tuition up to \$5.00 in academic year 2021-2022 and up to \$5.00 academic year 2022-2023
- Cincinnati State has not increased tuition in academic year 2021-2022
- Resolution 21.110 allows the College to raise tuition at a time determined by President Posey within the limits of HB110 to maintain a balance of educational quality and student success with the fiscal sustainability of the institution pursuant to the College's Strategic Plan
- College's Tuition compared to other regional institutions:







#### Tuition Increases Academic Year 2021-2022 and Academic Year 2022-2023

WHEREAS, Cincinnati State provides open access to exceptional and affordable technical and nontechnical higher educational offerings including bachelor's degrees, associate degrees and certificates that are consistent with the College's accreditation by the Higher Learning Commission, and

WHEREAS, the College continues to provide exceptional higher education at rates of tuition significantly lower than four-year institutions, and at comparable tuition rates to other Ohio Community Colleges, and

**WHEREAS**, House Bill 110 passed by the Ohio legislature and signed into law by the Ohio governor in 2021 allows Ohio Community Colleges to increase tuition and general fees \$5.00 in academic year 2021-2022 and \$5.00 academic year 2022-2023, and

WHEREAS, Cincinnati State has not raised tuition and general fees in academic year 2021-2022 as of the date of this resolution, and

**WHEREAS**, the Board of Trustees and College administration have concluded an increase in tuition and fees may be necessary to ensure the College maintains a balance of educational quality and student success with the fiscal sustainability of the institution pursuant to the College's Strategic Plan,

**NOW, THEREFORE BE IT RESOLVED**, The Board of Trustees hereby authorizes the College to increase tuition \$5.00 in academic year 2021-2022 and \$5.00 in academic year 2022-2023, consistent with House Bill 110, effective at College President's discretion, and upon consultation with the Finance Committee. The out-of-state surcharge shall be increased by the same amount. The College shall report such increase to the Board of Trustees via the Finance Report, or President's Report at the earliest practical Board meeting relative to such increase.

### **Capital Projects Resolution 21.111**

- Resolution 21.111 provides limited authorization to start four additional projects:
  - Main Building 1<sup>st</sup> Floor Assessment (suspended in March 2020 due to pandemic)
  - Clifton Campus Exterior Improvements
  - Harrison Campus Expansion Concepts
  - Butler County Long-Term Planning and Enrollment Study
- The Board of Trustees is authorizing up to \$350,000 to complete the next phases of these four projects and streamlines Board required procurement
- Resolution 21.111 was drafted with the counsel of the Board Chair (Mr. Vincent) and Board Member John Silverman





#### **Contract Authority for Specified Capital Projects**

WHEREAS, Cincinnati State administration have identified potential opportunities for capital improvements that represent potential enrollment growth, and are consistent with the College's Strategic Plan,

WHEREAS, Cincinnati State administration and the Board of Trustees have publicly deliberated allocations of capital appropriations and allocations of federal stimulus (including proceeds from lost revenue), and have identified sources of funding in excess of allocations to existing projects, and the administration and Board of Trustees would like to develop conceptual plans to implement additional projects focused on enrollment growth and the Strategic Plan,

WHEREAS, the Cincinnati State administration and Board of Trustees seek to prioritize and develop conceptual plans to accelerate the completion of the Clifton Campus Main Building Assessment related to the first floor of the Main Building, implement exterior improvements to the Clifton Campus, evaluate expansion of the Harrison Campus to support aviation programs, and evaluate the College's strategic presence and offerings in Butler County Ohio.

#### NOW, THEREFORE BE IT RESOLVED,

The Board of Trustees affirms the College's authority, under prior resolution, to utilize KZF to complete conceptual designs for the Clifton Campus Main Building Assessment. Such assessment was in progress but suspended due the health pandemic in the Spring of 2020.

The Board of Trustees hereby authorizes the College to initiate an RFQ for architectural and engineering services for exterior improvements to the Clifton Campus in an amount not to exceed \$150,000. The concepts and designs shall be designated by the College President in consultation with the Executive Team, College Community and Finance Committee. This resolution shall satisfy the College's obligation to present a contract to the Board of Trustees as long as the College follows Ohio and College procurement policy to procure service, or at the discretion of the President a portion of this amount may be paid to Butler Tech to defray costs for such study.

The Board of Trustees hereby authorizes the College to engage an architect in an amount not to exceed \$100,000 to develop conceptual designs for the expansion of Harrison Campus to accommodate additional cohorts of aviation students and other programs. Such architect may be funded via general fund, lost revenue stimulus, or capital funds at the discretion of the College President. This resolution shall satisfy the College's obligation to present a contract to the Board of Trustees as long as the College follows Ohio and College procurement policy to procure said architect.

The Board of Trustees hereby authorizes the College to engage architects and/or consultants in an amount not to exceed \$100,000 for the development of conceptual designs and feasibility studies regarding the College's long-term presence in Butler County. The College may use general funds, lost revenue stimulus, or capital funds and allocate funds at the discretion of the College President. This resolution shall satisfy the College's obligation to present contracts to the Board of Trustees as long as the College follows Ohio and College procurement policy to procure services.

**WHEREAS,** the College has complied with Ohio Revised Code, the Ohio Administrative Code, and/or Ohio Revised Code 123.10 in its procurement processes, and in doing so, recommends contracts for FY22 as follows:

- 2) IST Ohio, 4 FANUC engineering and manufacturing robots (compliments existing robots), funded from Rapid Grant 5 from State of Ohio, \$168,000;
- 3) HAAS Factory Outlet, 5 axis milling machine that will be used across multiple programs, funded from Rapid Grant 5 from State of Ohio, \$140,843.

# ACCREDITATION - HIGHER LEARNING COMMISSION INTERIM REPORT ON ASSESSMENT

The Interim Report provided HLC with additional evidence of the College's assessment infrastructure and the annual assessment data generated for each degree program from that 3-year assessment cycle. The HLC response to the Interim Report was extremely positive, as evidenced by the following quotes in the response.

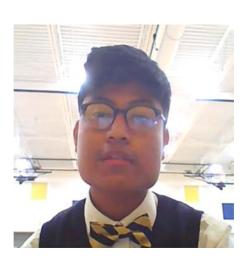
