




August 2021 Fiscal KPI Dashboard

FY22 Year-to-Date as of August 31, 2021 only includes the 3rd and 4th months of Summer Semester.



21.97 Vendor Contracts Approval



Resolution 21.97

WHEREAS, the Board of Trustees establishes expectations with regards to accountability and transparency, and has adopted a Contract Management Policy.

WHEREAS, the College has complied with Ohio Revised Code, the Ohio Administrative Code, and/or Ohio Revised Code 123.10 in its procurement processes, and in doing so, recommends contracts for FY22 as follows:

- 1) Select Aerospace Industries d/b/a Avotek, \$99,998.00 for training simulators for expanded Aviation Maintenance Program (Grant Funds);
- 2) Bansal Construction, \$65,984.24 for replacement of beacon light at Cincinnati West Airport (90% Grant Funds; 10% General Funds);
- 3) Baxter Hodell Donnelly Preston, Inc. (BHDP Architecture) \$199,950.00 for Architect/Engineer services for construction of Allied Health Simulation Lab (Capital Funds);
- 4) Blue Chip Facility Services, \$148,000.00 for seven month renewal of supplemental janitorial services (General Fund); this represents a correction to contract amount previously approved by the Board on August 24, 2021;
- 5) Clark Schaeffer Hackett, \$90,000.00 for annual financial audit (General Funds);
- 6) Engie Power & Gas, LLC, to secure fixed rate pricing for natural gas purchases by the College (General Fund);
- 7) KZF Design, Inc., \$87,500.00 for Architect/Engineer services for replacement of Main Building Gym Roof (Capital);
- 8) Precision Laser & Instrument Inc., \$117,357.63, surveying equipment for the Land Surveying program (Federal Stimulus Funds); purchase made through the Trimble University Partnership Program at 50% discount.

IT IS HEREBY deemed that the Board of Trustees of Cincinnati State Technical & Community College approves entering into contracts with the above to provide said goods and services.

Key Points:

- Complies with Ohio Department of Education's semester requirements
- Provides sufficient time, as demonstrated by current calendar, to onboard new students who matriculate in Spring
- Follows pattern of current academic calendar (holidays, start/end of semesters, etc.) with exception of an added spring break achieved by shortening summer semester from 15 weeks to 14 weeks.
- The Calendar Committee* will monitor student success data annually and, if warranted, recommend adjustments accordingly.



21.104 Amendment to Board By-Laws

- Pursuant to R.C. 3345.82, BOT member may attend BOT meeting virtually if:
- The electronic means allow for virtual attendee to interact and be heard by those attending meeting in person
- BOT member must provide at least 48 hours notice of intention to attend virtually
- At least 1/3 of the BOT members must be present in-person for any meeting at which there will be virtual attendance
- BOT members must attend a minimum of 50% of scheduled meetings in-person
